- 1985-01** A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.
- 1985-02** A RESOLUTION AUTHORIZING COUNCIL TO ENTER INTO AGREEMENT WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES TO ADMINISTER A CERTAIN GRANT FOR LITTER CONTROL.
- 1985-03** A RESOLUTION TRANSFERRING FUNDS FROM THE GENERAL FUND TO THE LITTER GRANT FUND.
