

# 1986 RESOLUTIONS

- 1986-01** A RESOLUTION AMENDING A PREVIOUS RESOLUTION SETTING THE LITTER GRANT SUPERVISOR'S SALARY AT \$7.25.
- 1986-02** A RESOLUTION TRANSFERRING FUNDS TO PROVIDE FOR THE DAILY OPERATION OF THE VILLAGE GOVERNMENT.
- 1986-03** RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.
- 1986-04** A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND CLERK/TREASURER TO ENTER INTO CONTRACT ON BEHALF OF THE VILLAGE OF BUCKEYE LAKE, OHIO, WITH THE BUCKEYE LAKE VOLUNTEER FIRE DEPARTMENT, INC., SO THAT FIRE PROTECTION CAN BE PROVIDED TO THE VILLAGE OF BUCKEYE LAKE, OHIO, FOR THE 1986 CALENDAR YEAR, AND DECLARING AN EMERGENCY.

- 1986-08** A RESOLUTION DECLARING NECESSITY FOR LEVY IN EXCESS OF TEN MILL LIMITATION AND DECLARING AN EMERGENCY.
- 1986-09** A RESOLUTION TRANSFERRING PREVIOUSLY APPROPRIATED FUNDS FOR THE DAILY OPERATION OF VILLAGE GOVERNMENT.
- 1986-10** A RESOLUTION AUTHORIZING THE HIRING OF JAMES SLOCUM AS STREET SUPERVISOR AND SETTING SAID SUPERVISOR'S HOURS AND WAGES.
