## **1989-01** ANNUAL APPROPRIATION ORDINANCE.

NEEL'S ALLOTMENT ADDITION ADJOINING BUCKEYE LAKE PARK; SEE VOLUME 3 AT PAGE 313, AND VOLUME 4 AT PAGE 60 LICKING COUNTY PLAT RECORDS, SAID STREET BEING BOUNDED BY LOT 7 IN THE SUSAN W. NEEL'S ALLOTMENT ADDITION ADJOINING BUCKEYE LAKE PARK AND LOT NUMBER 115 IN THE SECOND ADDITION OF SUSAN W. NEEL'S ALLOTMENT ADDITION ADJOINING BUCKEYE LAKE PARK.

- **1989-11** AN ORDINANCE AMENDING ORDINANCE NUMBER 1987-13 BY CHANGING THE LOCATION OF PUBLIC POSTING PLACES WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO.
