- 1989-01** AN INTERIM APPROPRIATION RESOLUTION FOR THE VILLAGE OF BUCKEYE LAKE, OHIO MAKING APPROPRIATIONS FOR THE FIRST THREE (3) MONTHS OF THE YEAR, 1989, AND DECLARING AN EMERGENCY.
- 1989-02** A RESOLUTION DECLARING IT NECESSARY TO CONSTRUCT A PUBLIC WATER SYSTEM IN THE VILLAGE OF BUCKEYE LAKE, OHIO, AND AUTHORIZING THE APPLICATION FOR PLANNING FUNDS FROM THE STATE OF OHIO, EMERGENCY VILLAGE CAPITAL IMPROVEMENT SPECIAL ACCOUNT.
- 1989-03** A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.

NEEL'S ALLOTMENT ADDITION ADJOINING

BUCKEYE LAKE PARK AND LOT NUMBER 115 IN THE SECOND ADDITION OF SUSAN W. NEEL'S ALLOTMENT ADDITION ADJOINING BUCKEYE LAKE PARK.
