- 1991-01** A RESOLUTION APPOINTING A SOLICITOR FOR THE VILLAGE OF BUCKEYE LAKE; FIXING HIS COMPENSATION AND DUTIES AND WAIVING RESIDENCY REQUIREMENTS.
- 1991-02** AN INTERIM APPROPRIATION RESOLUTION FOR THE VILLAGE OF BUCKEYE LAKE, OHIO MAKING APPROPRIATIONS FOR THE FIRST THREE (3) MONTHS OF THE YEAR 1991 AND DECLARING AN EMERGENCY.
