April 15, 2020 Meeting Minutes

COMMITTEES SHALL GIVE REPORTS IN THE FOLLOWING ORDER:

<u>Public Service Committee:</u> Councilor French called the committee meeting to order at 6:34pm. He stated that Mr. Miller received bids and Shelly Company was the low bidder at \$93,337.00. The average bid was \$103,000. He stated that the bids include FDR & overlay for the project.

Mr. Miller stated that Highland, Central, Lake and the area where the stormwater project is finishing up will be addressed.

Councilor French asked the committee for a motion to move the legislation to award the bid to council.

Motion by Councilor Cable and seconded by Councilor Lemmon to move the legislation to award the bid to council. Motion approved 4-0. The Public Service Committee meeting ended at 6:38pm.

Finance Committee: Councilor Lemmon called the committee meeting to order at 6:38pm. He stated that originally the paving and trench repair project was funded at \$50,000 per year. Council added an extra \$50,000 of new operation levy money to the project. There is a need to transfer money for the additional \$50,000 of project money.

Motion by Councilor French and seconded by Councilor Goodman to transfer fund for the paving and trench repair project. Motion approved 4-0. The Finance Committee meeting ended at 6:51pm.

Personnel Committee: Councilor Goodman called the committee meeting to order at 6:44pm. She stated that they have reviewed several resumes of candidates around the area and throughout the state. She stated that it quickly became apparent that they were going to have to have to improve the incentives to get a quality person. Therefore, they are asking for a salary increase for the potential candidate. Councilor Goodman stated that the pay for the position will

be \$2,200/every two weeks. She stated that they feel that the potential candidate will be a good fit as they have experience in the fiscal part of the job as well as human resources.

Council Clerk Hans asked for clarification on the salary for the position. She stated that Ordinance 2020-20 shows the salary at \$2,240/every two weeks while the committee is discussing \$2,200/every two weeks.

Councilor Goodman clarified that the salary will be \$2,240/every two weeks.

Councilor French asked if it looks like the person will stay for a while?

Councilor Goodman stated that the person has been at the same entity for the past 20 years. They live locally and are not a job hopper.

Council President Geiger stated that he feels the person will be around for a while.

Councilor Goodman stated that the person will work 40 hours a week for the Clerk/Treasurer position. She then asked if there were any questions or discussion?

Councilor Cable asked if the person would have any other duties.

Councilor Goodman stated that they would have some HR duties as well included in their position.

The Personnel Committee voted unanimously to move the legislation forward to council.
