Councilor Lemmon plans to schedule a committee meeting to look at the general fund as Mayor Wells needs some funding to take out blanket POs for utilities. He will get with his committee to schedule the date for the meeting.

<u>Public Service Committee:</u> Councilor French stated that the 5/4/2020 meeting at 6:30pm will be to provide a detailed overview of the project and do questions and answers for phase II of the project.

<u>Community Development Committee:</u> Councilor Zwissler stated that there are 14 vacant businesses. The space where Ray King is located will be vacated and split into two retail spaces.

Hospitals and dentists will be the first to open up for elective procedures. On 5/4/2020 manufacturing and distribution businesses will be opening back up and on 5/12/2020 retail and consumer services will be opening back up.

Council President Geiger stated that Tasty Taste opened in the old Dairy Aisle space. He stated that they had food from there last week and it was very good.

Councilor Zwissler stated that Papa Boo's opens this Wednesday for carry out only.
