Councilor Lemmon stated this was discussed at the finance committee meeting. We need a medic. This has been talked about for the past 18 months.. the fire department has the money. It will not affect the budget. We do not want the old vehicle to break down.

Councilor Zwissler stated there is no fire chief, they are asking us to put the village in debt. We ae buying this in Pennsylvania and financing in Indiana. The village is already in debt for two police vehicles. The Fire department is not taking any runs, I agree we don't want them to pour money into and vehicle.

Councilor Lemmon stated we would be financing 195,840 through Park National Bank, a local bank, and Interest 2.74% \$38,840/year. We can budget that. It is manufactured in Pennsylvania.

Councilor Cable stated this proposal did not go through the public safety committee. They did not get to take a look at this, this needs to be postponed. Part of personnel is to bring this resource to the committee.

Councilor Goodman to Mr. Ruton this wasn't brought to Public Safety My first question is there are no chiefs' name of signature attached to this.

Safety Chair, Melissa Beard, if we need to meeting we would welcome a meeting.
