

Mayor's Report
Village of Buckeye Lake
June 28, 2021

1. Councilor Lemmon and Councilor Zwissler toured my Cranberry Bay property personally so I could address their questions regarding some drainage issues in the neighborhood. They both left satisfied that I was not causing run off onto property owned by others.
2. The ribbon cutting ceremony for the new Pavilion was held on June 19. We had 87 in attendance in spite of the light rain. We presented Senator Tim Schaffer with a proclamation for his efforts in supporting the state funding and sustaining it in the state's capital budget over a period of four years. This funding of \$125,000 was originally tagged as "Streetscape Funding" with a requirement that it have a cultural and/or historic element. It was supervised by the Ohio Facilities Construction Commission. We used the value of our land to satisfy the 50% match.

Licking County Auditor Michael Smith attended the ribbon cutting ceremony with his family. Hebron's Mayor Jim Layton and Village Administrator Vince Popo also attended. Thanks to Council President John Geiger and Councilors Linda Goodman and Kitty Zwissler for attending. Local singer, songwriter and producer David Spires entertained us after the ribbon cutting.

I need to recognize Parks and Rec Commissioner Barb Sills for all her help in organizing and carrying out this event. Barb arranged for guests to have a little keepsake of the event - a professional photo of the Pavilion printed on a magnet. She's also given us the rights to use this great photo. It was used on the program and I'm sure we'll use it well into the future. I'd also like to thank volunteers Maureen Collins, Bobbie Dickerson and Susan Blanke.



He will be going to Wellston, Ohio for a higher rate of pay. I appreciate that the Personnel Committee plans to review our department's salaries.

8. The gutters on the rear of the municipal building were replaced this morning by Joe Yoder at a cost of \$1106.00. After the rain today, it was determined they did a great job. The job also included the small roof over the rear door to the office.
