AN ORDINANCE AMENDING ORDINANCE 85-2, THE VILLAGE ANNUAL APPROPRIATION ORDINANCE.

WHEREAS, this Ordinance is designed to correct said error.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The Block Grant Program, B5-A Line 211 which currently reads \$1,100.00 is hereby amended to read \$2,156.00. Line 240 which currently reads \$0.00 is hereby amended to read \$105.00. Total federal grant which currently reads \$1,100.00 is hereby amended to read \$2,261.00. Grand total special revenue funds appropriation which currently reads \$54,207.00 is hereby amended to read \$55,368.00. Total all appropriations which currently reads \$259,767.00 is hereby amended to read \$260,928.00.

Section 2: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
