

ORDINANCE NUMBER 90-11

AN ORDINANCE CHANGING THE NAMES OF CERTAIN STREETS WITHIN THE VILLAGE OF BUCKEYE LAKE.

WHEREAS, Council desires to change the names of certain streets to eliminate duplicate names and the resulting confusion.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1: Within the Neel Essex Addition there are First Street, Second Street, Third Street, Fourth Street, Fifth Street, Sixth Street and Seventh Street. The names of these streets are changed to West First, West Second, West Third, West Fourth, West Fifth, West Sixth and West Seventh Streets, respectively.

SECTION 2: Within the Myers Addition Sixth ~~Street~~ <sup>Ave</sup> and Park Street are changed to East Sixth and East Park Streets, respectively.

SECTION 3: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
