

## ORDINANCE 2015-21

### AN ORDINANCE AMENDING ORDINANCE 2013-26 AND ESTABLISHING NEW WATER RATES AND COLLECTION GUIDELINES FOR THE VILLAGE OF BUCKEYE LAKE WATER DISTRIBUTION SYSTEM.

WHEREAS, the Village of Buckeye Lake needs to increase the Water Rates due to an increase in the Water Rates incurred from the Village of Millersport.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Buckeye Lake, Ohio as follows:

Section 1: That Ordinance 2013-26 is hereby AMENDED and shall read as follows:

Damaged Meters Repair

¾ to 1 inch        \$50.00 plus parts  
 1.5 inch and up    labor & parts  
 (If not repairable will incur cost of new meter)

Section 4: The Village reserves the right to review and revise their rate structure as needed.

Section 5: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
