

**VILLAGE OF BUCKEYE LAKE, OHIO
ORDINANCE NUMBER 2019-41**

**AN ORDINANCE TO TRANSFER FUNDS COLLECTED FOR THE GRANT
CONSTRUCTION PROGRAM AND DECLARING AN EMERGENCY**

WHEREAS, the Council of the Village of Buckeye Lake has authorized by Resolution 2018-01 the match of grant funding of the Transportation Alternatives Program (TAP); and

WHEREAS, the Council of the Village of Buckeye Lake deems it necessary to transfer Funds to the Grant Construction Fund (4201) to allow for the match of grant funding of the Transportation Alternatives Program (TAP) as set forth in Resolution 2018-01;

WHEREAS, the Transfer Out Appropriations established below has sufficient funds to cover this transfer.

NOW THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, Licking County, OHIO:

SECTION I: That to provide for the current expenses and other expenditures of the Village of Buckeye Lake during the fiscal year ending December 31, 2019, the following sums be and are hereby set aside, appropriated and transferred as follows:
