## **ORDINANCE NUMBER 2020-06**

AN ORDINANCE AUTHORIZING THE PURCHASE OF NEW FILE SERVER AND EXCHANGE SERVER TO SUPPORT THE TECHNOLOGY REQUIREMENTS OF THE VILLAGE OF BUCKEYE LAKE, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Buckeye Lake has requirements to maintain the latest computer technology; and

WHEREAS, the Village of Buckeye Lake must keep current all software and hardware to guard against security breaches of all public and private information stored on electronic formats; and

WHEREAS, the Village of Buckeye Lake must provide for and ensure continuity of operations of our electronic systems; and

WHEREAS, this purchase of new server is under the state bid threshold, and more than one proposal was received from current technology vendors.

THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

## BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

SECTION I: The Mayor is hereby authorized and directed to have the Clerk Treasurer authorize the expenditure for purchase and setup of new severs from Alpha Link Technologies in the amount of twenty-one thousand six hundred sixty-six dollars (\$21,669.00).

SECTION II: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Buckeye Lake which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

SECTION III: That this ordinance is hereby declared to be an emergency necessary for the public health safety and welfare, such emergency arising from the severs being out of date for security updates and support, and therefore, shall take effect and be in force from and after its adoption by council and approved by the Mayor.
