SECTION I: That the bid of Kendrick Excavating. for the Village of Buckeye Lake North Bank Rd East Stormwater Improvements Project is hereby APPROVED as attached Exhibit "A", and the contract is hereby awarded to said successful bidder.

SECTION II: That the mayor be, and hereby is, directed to execute said agreement with Kendrick Excavating for base bid amount of \$834,410.80 pending funding.

SECTION III: This ordinance shall take effect and be in force at the earliest date allowed by law.
