

ORDINANCE 2021-08
VILLAGE OF BUCKEYE LAKE

PERMANENT ANNUAL APPROPRIATIONS ORDINANCE OF THE VILLAGE OF BUCKEYE LAKE, OHIO, FOR 2021, AND THE DECLARATION OF AN EMERGENCY.

WHEREAS, the Village of Buckeye Lake, Ohio, desires to make permanent appropriations for current expenses and other expenditures during the fiscal year ending December 31, 2021;

NOW THEREFORE, at least two-thirds (2/3) of Council concurring to dispense with the requirements of Charter Section 4.04 requiring three readings of an ordinance on three separate days with at least one week between the readings,

BE IT NOW ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

Section I. That to provide for the current expenses and other expenditures of the said Village of Buckeye Lake during the fiscal year ending December 31, 2021, the sums be and they are hereby set aside and appropriated on the attached Exhibit "A."

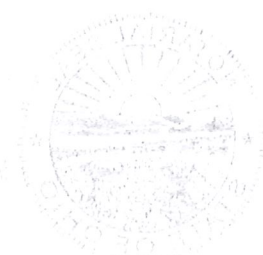

Due to the approaching due date for submission of this ordinance to the Licking County Auditor, this ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, morals, and welfare of the citizens of Buckeye Lake, Ohio. Therefore, this ordinance shall become effective upon its passage by Council.

CERTIFICATE
