**AN ORDINANCE AMENDING ORDINANCE 2020-12 CREATING PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO AND DECLARATION OF EMERGENCY.**

Be It Ordained by the Village of Buckeye Lake, State of Ohio:

2021-12 is amended and the following pay levels and schedules are hereby adopted:

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, STATE OF OHIO, THAT:**

SECTION I: That the following pay levels and schedules are hereby adopted.
