AN ORDINANCE AMENDING ORDINANCE 2021-37 CREATING PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO AND DECLARATION OF EMERGENCY.

Be It Ordained by the Village of Buckeye Lake, State of Ohio:

2021-37 is amended and the following pay levels and schedules are hereby adopted:

SECTION I: That the following pay levels and schedules are hereby adopted.
