A RESOLUTION AMENDING THE 1985 INTERIM APPROPRIATION RESOLUTION.

Section 1: The 1985 Interim Appropriation Resolution is hereby amended to include a category entitled State Litter Grant and funds shall be appropriated to said category as follows:

Section 2: To handle funds received for the Village's Code Enforcement Grant, a category entitled Code Enforcement is hereby created and funds shall be appropriated to said category as follows:

210 - Personal Service	980.00

212 - Benefits	\$ .00
220 - Travel	\$ .00
240 - Operation & Maintenance	\$ 120.00
TOTAL	<u>\$1,100.00</u>

Section 3: A transfer is hereby made within the General Fund of \$780.00 from Line A16B-240 to A11A-250.

Section 4: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
