- Section 3: Four hundred dollars (\$400.00) is hereby transferred from Recreation, A13A211, to Lands and Buildings, Operations and Maintenance, A17E240.
- Section 4: Eighty-five dollars (\$85.00) is hereby transferred from Recreation, A13A212, to Lands and Buildings, Operations and Maintenance, A17E240.
