

A RESOLUTION ADOPTING THE COUNTY HOUSE NUMBERING SYSTEM.--

WHEREAS, Council desires to have a uniform system of house numbering to assist emergency responses from the fire department in coordination with the new 911 number; and

WHEREAS, Council notes that there are some discrepancies between the county system and that which has been used historically within the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1: The County Engineer's numbering system is hereby adopted for the Village of Buckeye Lake, Ohio.

SECTION 2: A copy of such numbering system is attached hereto and is available for inspection in the Buckeye Lake Village Clerk's Office.

SECTION 3: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
