A RESOLUTION ESTABLISHING A FIRE DEPARTMENT FOR THE VILLAGE OF BUCKEYE LAKE, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, Section 737.22 of the Ohio Revised Code grants to the legislative authority of a village the power to establish and maintain a fire department; and

WHEREAS, the Village will be without fire protection on January 1, 1991, due to the expiration of a contract for fire protection heretofore had with a not-for-profit private corporation; and

WHEREAS, an emergency exists due to the breakdown in negotiations with the private corporation and in order to protect the health, safety and welfare of the Village, immediate steps must be taken to provide fire protection.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1: Pursuant to Ohio Revised Code Section 737.21, the Village Council hereby creates a municipal volunteer fire department. Such fire department shall come into immediate existence for the purpose of providing fire protection to the inhabitants of the Village.

SECTION 2: An emergency squad unit is also created under the jurisdiction of the fire department. Funds heretofore used for fire protection may be used to equip the emergency squad service.

SECTION 3: Council consents to the appointment of Kould as fire chief. Such individual being heretofore appointed by the Mayor.

SECTION 4: Compensation for such fire chief shall be -0 - per annum.

SECTION 5: Council sets the number of volunteer fire fighters at <u>50</u>. The Mayor shall appoint no more than this number unless specifically authorized to do so.

SECTION 6: All appointments as authorized shall be made pursuant to 737.23 of the Ohio Revised Code.

SECTION 7: For the reasons stated in the preamble hereto which is made a part hereof, this Resolution is declared to be an emergency measure and shall go into immediate effect.
