## RESOLUTION NO. 2025-01 VILLAGE OF BUCKEYE LAKE FIRST READING

A RESOLUTION DECLARING CERTAIN FIRE VEHICLES SURPLUS PROPERTY AND AUTHORIZING THE MAYOR AND FISCAL OFFICER TO SELL SAID VEHICLES AT AUCTION AND THE DECLARATION OF AN EMERGENCY.

WHEREAS, the Village has received a recommendation from the Fire Chief that the following fire vehicles are no longer needed for public use, are obsolete, or are unfit for the use for which they were acquired and thus are surplus property and should be disposed of:

## 1999 Pierce Fire Engine - VIN: 4P1CT02M8XA001395

WHEREAS, this Resolution is offered pursuant to Revised Code §721.15, authorizing the sale of surplus Village property, including vehicles, which is no longer needed for public use, obsolete, or unfit for the use for which it was acquired, by Internet auction; and

WHEREAS, Council authorizes the Mayor and Fiscal Officer to sell, at Internet auction, the surplus fire vehicles identified herein;

NOW THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, AT LEAST TWO-THIRDS (2/3) OF ITS MEMBERS CONCURRING TO DISPENSE WITH THE REQUIREMENTS OF CHARTER SECTION 4.04 REQUIRING THREE READINGS ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN THE READINGS:

**SECTION 1:** The following vehicles used by the Fire Department are hereby declared surplus property, no longer of useful service to the Village and thus are available for disposition by Internet auction:

## 1999 Pierce Fire Engine - VIN: 4P1CT02M8XA001395

**SECTION 2:** The Mayor and Fiscal Officer are hereby authorized and directed to sell the above listed vehicles at Internet auction, for the best possible price, and to apply the proceeds of the sale to the Fire Department Fund 2901-961-0000 – Sale of Fixed Assets.

SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council, and any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of R.C. §121.22.

<u>SECTION 4:</u> For the reasons in the preamble, this resolution is deemed to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of the citizens of Buckeye Lake, Ohio. Therefore, this resolution shall become effective immediately upon its passage by Council.
